### PREFACE

This Standard was prepared by the Joint Standards Australia/Standards New Zealand Committee WS-028—Design and Installation of Buried Flexible Pipes.

This Standard incorporates Amendment No. 1 (June 2013), Amendment No. 2 (May 2018) and Amendment No. 3 (November 2018). The changes required by the Amendments are indicated in the text by a marginal bar and amendment number against the clause, note, table, figure or part thereof affected.

This Standard is Part 2 of AS/NZS 2566 Buried flexible pipelines. The Parts are as follows:

Part 1: Structural design—Commentary

Part 2: Installation (this Standard).

The purpose of Amendment 2 to AS/NZS 2566.2 is to update the text to reflect changes in AS/NZS 2566.1 Amendment 1, and to make editorial corrections.

Additionally, errors in Table 6.1 have been corrected.

The objective of this Standard is to provide designers and installers with uniform procedures for the installation of buried flexible pipelines.

Informative appendices and notes, except as mentioned above, use the word 'should' (implying for information and guidance only), whereas normative appendices, clauses, figures and tables use the word 'shall' (implying a mandatory requirement).

Where the term 'specified' has been used, but no reference given to where the requirement is to be found, the requirement is expected to be stated or referred to in other project documentation.
