#### **PREFACE**

This Standard was prepared by the Joint Standards Australia/Standards New Zealand Committee CS-018, Safety of Children's Toys.

This Standard incorporates Amendment No. 1 (January 2010). The changes required by the Amendment are indicated in the text by a marginal bar and amendment number against the clause, note, table, figure, or part thereof affected.

The objective of this Standard is to provide toxicity requirements for toys and toxicity labelling requirements for certain materials used in toys.

This Standard is an adoption with national modifications and has been reproduced from ISO 8124-3:1997, *Safety of toys*, Part 3: *Migration of certain elements*, and has been varied to take account of Australian/New Zealand conditions. Variations are set out in Appendix ZZ.

As this Standard is reproduced from an international publication, the following applies.

- (a) Its number appears on the cover and title page while the International Standard number appears only on the cover.
- (b) In Clause 1.1 of the source text, insert the word 'only' before the word 'specific'.
