This Interim Joint Australian/New Zealand Standard was prepared by the Joint Standards Australia/Standards New Zealand Committee WS/20, Stormwater.

The date of expiry for comment is two years after publication, at which time this Interim Australian/New Zealand Standard will be confirmed, withdrawn or revised in the light of public comment, or published as a Joint Australian/New Zealand Standard. During the life of this document the committee will monitor all comment as it is received.

The objective of this Interim Standard is to provide manufacturers with requirements for non-metal rainwater goods and accessories to determine fitness for purpose.

The test criteria specified apply to pipes and fittings at the time of manufacture and should not be used to assess the results from tests on pipes or fittings which have been in service.

The AS 1462 series at the time of publication of this Standard is in the process of a Joint Standards Australia/Standards New Zealand review and will be published as a AS/NZS 1462 series. As these are published the AS 1462 documents referenced in this Standards should be replaced by the equivalent AS/NZS 1462 document.

The terms 'normative' and 'informative' have been used in this Standard to define the application of the Appendix to which they apply. A 'normative' Appendix is an integral part of a Standard, whereas an 'informative' Appendix is only for information and guidance.
