This Standard was prepared by the Standards Australia Committee on Railway Permanent Way Material to supersede AS 1085.1—1981.

Major alterations to the previous edition are as follows:

- (a) Amendments to the rolled-in brands and stamped brands clauses for identification.
- (b) The addition of a clause on surface defects.
- (c) The addition of 50 kg and 60 kg rolled steel asymmetrical switch rails and 50 kg and 60 kg rolled steel guardrails.
- (d) Minor editorial amendments.
