This Standard was prepared by the Joint Australia/New Zealand Standards Committee WS/1, Water Fittings, to supersede AS 3718—1992 and covers taps that are specified by performance. Taps that are specified by dimension are covered in AS 1718.

This Standard incorporates Amendment No. 1 (June 2000). The changes required by the Amendment(s) are indicated in the text by a marginal bar and amendment number against the clause, note, table, figure, or part thereof affected.

The objective of this revision is to issue it as a Joint Australian/New Zealand Standard and incorporate amendments and additions arising from industry requirements.

The terms ‘normative’ and ‘informative’ have been used in this Standard to define the application of the appendix to which they apply. A ‘normative’ appendix is an integral part of a Standard, whereas an ‘informative’ appendix is only for information and guidance.
