## PREFACE

This Standard was prepared by the Joint Standards Australia/Standards New Zealand Committee QR-008, Quality Management Systems.

*This Standard incorporates Amendment No. 1 (February 2012). The changes required by the Amendments are indicated in the text by a marginal bar and amendment number against the clause, note, table, figure or part thereof affected.*

This Standard is identical with, and has been reproduced from ISO 9001:2008, *Quality management systems—Requirements*, published by the International Organization for Standardization (ISO), which was prepared by ISO Technical Committee TC 176, Quality Management and Quality Assurance, Subcommittee SC 2, Quality Systems. Committee QR-008 provided input to the ISO Committee during the preparation of this revision.

This fourth edition of AS/NZS ISO 9001 replaces AS/NZS ISO 9001:2000, which will remain available until December 2011.

The objective of the revision is improved clarity, within the overall requirement that an organization that has fully implemented ISO 9001:2000 should not have to make changes to its quality management system in order to comply with the new edition. This edition enhances compatibility with ISO 14001:2004 and hence the Australian adoption AS/NZS ISO 14001:2004 on environmental management systems. Details of specific changes between the third edition and this fourth edition are given in Annex B.

As this Standard is reproduced from an International Standard, the following applies:

- (a) Its number appears on the cover and title page while the International Standard number appears only on the cover.
- (b) In the source text ‘this International Standard’ should read ‘this Australian/New Zealand Standard’.
- (c) A full point substitutes for a comma when referring to a decimal marker.

References to International Standards should be replaced by references to Australian or Australian/New Zealand Standards, as follows:
