PREFACE

This Standard was prepared by the Standards Australia Committee AG-010, Natural Gas Quality Specifications to supersede AS 4564—2005.

The principal changes from the 2005 edition of this Standard are as follows:

- (a) Additional normative limits on higher heating value and on oil.
- (b) Additional information on the derivation of the new normative limits on higher heating value and on oil.
- (c) Additional information on other contaminants including informative limits for elemental sulphur, mercury and radioactivity.
- (d) Updating of the information on the derivation of the normative limits that remain unchanged from the 2005 edition.

The terms ‘normative’ and ‘informative’ have been used in this Standard to define the application of the appendix to which they apply. A ‘normative’ appendix is an integral part of a Standard, whereas an ‘informative’ appendix is only for information and guidance.
