Forfás in exercise of the power conferred by section 20 (3) of the Industrial Research and Standards Act, 1961 (No. 20 of 1961) and the Industrial Development Act, 1993 (No. 19 of 1993), and with the consent of the Minister for Enterprise and Employment, hereby declares as follows:

1. This instrument may be cited as the Standard Specification (Materials and Articles in Contact With Foodstuffs – Plastics – Part 3: Test Methods for Overall Migration into Aqueous Simulants by Total Immersion) Declaration, 1994.
2. (1) The Specification set forth in the Schedule to this declaration is hereby declared to be the standard specification for Materials and Articles in Contact With Foodstuffs – Plastics – Part 3: Test Methods for Overall Migration into Aqueous Simulants by Total Immersion. The Schedule comprises the text of ENV 1186-3 : 1994.

(2) The said standard specification may be cited as Irish Standard/ENV 1186-3:1994 or as I.S./ENV 1186-3:1994.

CEN members are the national standards bodies of Austria, Belgium, Denmark, Finland, France, Germany, Greece, Iceland, Ireland, Italy, Luxembourg, Netherlands, Norway, Portugal, Spain, Sweden, Switzerland and United Kingdom.
